

Dear Mr. Bjordnal,

Thank you for reaching out with your letter regarding annual maintenance and storm sewer concerns.

With the shift from the winter months, our annual spring and summer maintenance plans have begun. Sweeping, mowing, and brushing will be actively working throughout the entire service area in the upcoming months. These works will be performed by O'brien Road & Bridge and MOTI approved sub-contractors. While growing vegetation may seem unsightly, safety is our highest priority. Vegetation control works encroaching on a 1.8m from shoulder edge specification will be prioritized for adequate driver sight lines.

Our maintenance contractors are required to inspect, clean, and maintain all culverts except for access and non-MOTI road culverts. Storm sewer maintenance and cleaning of storm infrastructure are the responsibility of the local municipality. We appreciate a strong working relationship between our maintenance contractors and local municipalities for overlapping maintenance activities.

The Board asked questions and Ms. Collison and Ms. Wilson responded accordingly. The Chair of the Board thanked Ms. Collison and Ms. Wilson.

Board Business:

Dear Councillor or Mayor,	(OMC) Recom:

My name is Nathan Bird and I am writing to you on behalf of the <u>Victoria Transit Riders Union</u> (a grassroots organization advocating for fare-free, rapid, and reliable public transit) in light of the resolution recently passed unanimously by Saanich Municipal Council requesting that the Union of British Columbia Municipalities (UBCM) lobby the provincial government to make public transit fare-free for youth aged 18 and under across BC. Another similar resolution for free transit for BC seniors (aged 65 and older) is scheduled for a vote by Saanich Council on June 10th.

The Victoria Transit Riders Union heartily supports these resolutions (attached) and humbly asks you to consider putting forward similar motions to Port Edward Municipal Council at your earliest possible convenience.

If your council should pass these resolutions it would greatly strengthen the case for free public transit for all youth and seniors going into this September's UBCM conference and, subsequently, increase pressure on the provincial government to grant this request, which we believe is in the best interests of communities and ecosystems across the province and around the world. At a stroke, expanding fare-free ridership to these age groups would increase accessibility and inclusivity in your municipality, and could reduce personal vehicle use, helping you hit your emissions reduction targets and improving road safety and traffic congestion. And these benefits would come at no increased cost to your municipality but would be underwritten by the province.

Furthermore, we believe that these measures would ultimately save BC taxpayers money by reducing costs in areas like healthcare and infrastructure.

In the future we hope to see conversations at the municipal and provincial levels about transit that is both excellent and completely fare-free as these benefits would be even greater if fare-free transit extended to people of all ages.

The Victoria Transit Riders Union thanks you for your time and consideration, and looks forward to Port Edward joining Saanich in leading the province toward a greener, healthier, and more inclusive future!

PURPOSE:

The purpose of this report is to provide background information on the context for supporting the adoption of a draft UBCM resolution calling on the provincial government to make all public transit free for seniors.

BACKGROUND:

On July 1, 2023, Montreal launched a program that offered free public transportation fares to people aged 65 and older. In the first six months of the program the City of Montreal reported that "the number of trips taken by those in the target age group surged between 15 and 20 per cent," and that "forty-seven per cent of eligible Montreal-area residents had signed up for the program by the end of 2023."

The success of Montreal's program provides a compelling argument for why a similar program should be implemented across BC. The surge in transit use among seniors as a result of the program suggests that cost was a significant factor restricting seniors from travelling, and furthermore that free transit encourages greater mobility and accessibility for this demographic.

Increasing mobility for seniors enhances their ability to access essential services, and participate in social, recreational, and cultural activities. As a result, this policy not only improves quality of life, health, and well-being, but also helps foster a more inclusive and vibrant community.

The affordability crisis is impacting everything, and transportation costs continue to increase. The cost of transportation can be a significant barrier to someone's mobility, especially someone with a low or fixed income. Making transit free for seniors allows seniors to travel in a convenient and affordable fashion.

Montreal implemented a universal free transit program, and the universal nature of the program was a contributor to its success. A universal program with broad eligibility criteria is easy to administer and easy for members of the public to access and enjoy. On the other hand, means tested programs are complicated, administratively burdensome and expensive to implement.

BC currently has a program that provides a bus pass for people ages 60 and older,² but this program is aimed specifically at people with low incomes, and only provides people with a pass at a reduced cost. The program has strict eligibility requirements and an application process.

If you have a means test, an application process is required, someone needs to administer that test, people can fail to pass the test, resulting in people potentially falling through the cracks. Such programs also require those wishing to access them to navigate an often complicated and time-consuming application process. This process can serve as an additional barrier, not to mention potentially stigmatise those participating.

Overall, the Montreal experience demonstrates that making transit free for seniors can be both financially feasible and socially beneficial. Such programs are also environmentally beneficial. The *Clean BC Roadmap to 2030* has targets to reduce light-duty vehicle-kilometres travelled 25% by 2030, and increase walking, bicycling and public transit mode shares to 30% by 2030, 40% by 2040, and 50% by 2050.³ These goals are necessary if we are going to achieve our emissions reductions targets.

As seen in the Montreal case, removing barriers to people accessing transit increases their use of transit. As a result, making transit free for senior will encourage transportation mode shift towards increased transit use in BC. It is noteworthy that there are also other models that could be adopted or used as part of a phase in of the program. For example, the City of Barrie, Ontario, has free transit for seniors on Tuesday and Thursdays.⁴

Free transit for seniors has numerous benefits, including:

Accessibility: Many seniors in BC face financial constraints, and transportation costs can be a significant burden. Free transit enables them to access essential services like healthcare appointments, grocery shopping, and community events without financial strain.

Social Inclusion: Transportation barriers often contribute to social isolation among seniors, impacting their mental and physical well-being. Free transit encourages seniors to stay active in their communities, attend social gatherings, and maintain connections with friends and family.

Health Benefits: Accessible transportation promotes active lifestyles among seniors, encouraging them to engage in physical activity and recreation activities, thereby reducing the risk of chronic diseases associated with sedentary behaviour.

Environmental Impact and Encouraging Mode Shift: Encouraging seniors to use public transit helps reduce the number of single-occupancy vehicles on the road, lowering carbon emissions. This aligns with the province's transportation mode shift goals and GHG reduction targets.

Driver Safety: Free transit for seniors contributes to driver safety by potentially reducing the number of older adults driving when it may not be safe for them to do so. By offering an accessible and cost-effective alternative, BC can help ensure that seniors who may have diminished abilities can still travel safely and independently without risking accidents on the road.

Reduced Traffic Congestion: Free transit for seniors can help alleviate traffic congestion in urban areas by encouraging more seniors to use public transportation instead of driving. This can lead to smoother traffic flow, shorter commute times, and improved overall transportation efficiency for everyone, not to mention reduced emissions.

Economic Stimulus: Free transit for seniors can boost local economies by facilitating their participation in shopping and recreational activities. This increased spending can support local businesses and contributes to economic growth in communities.

Active Aging: Access to free transit encourages seniors in British Columbia to remain active and engaged in their communities. By providing a convenient and affordable means of transportation, seniors are more likely to participate in recreational activities, volunteer work, and other opportunities for personal enrichment, promoting active aging and enhancing their quality of life and fostering community.

Equity and Social Inclusion: Providing free transit for seniors promotes equity by ensuring that all seniors, regardless of socioeconomic status, have equal access to transportation options. It helps create more inclusive communities where everyone can participate fully.

SUMMARY:

There are numerous benefits to increasing access to public transit for seniors. These benefits include increasing access to essential services, increased social inclusion, health benefits, positive environmental impact, encouraging a shift towards more sustainable modes of transportation, improving driver and road safety, reducing traffic congestion, helping local economies, supporting active aging, equity, and inclusion. These benefits are maximized with a program that makes transit free for senior across the province. For this reason, it is recommended that Council adopt this draft UBCM resolution calling on the province to make public transit free for seniors.

Financial Implications

There are no financial implications for Saanich.

Strategic Priorities

This policy supports a number of strategic priorities, including:

- Climate action and environmental leadership by encouraging a shift towards more sustainable modes of transportation.
- Community well-being promoting health, inclusion equity, active aging, road safety, and affordability.
- Economic development supporting local businesses.

RECOMMENDATION:

That Council adopt the following draft UBCM resolution:

WHEREAS transportation costs can serve as significant barrier to mobility for many British Columbian seniors, and this barrier can contribute to social isolation and adversely affect mental and physical well-being;

AND WHEREAS removing barriers to seniors using transit encourages a shift towards more sustainable transportation, helping lower emissions and reducing congestion, while simultaneously increasing affordability, access to essential services, social inclusion, health, and well-being;



Backgrounder

The *Get On Board!* program currently allows children aged 12 and under to ride all BC Transit and TransLink transit services free of charge. Under this program children aged 6 to 12 are able to ride conventional and handyDART buses for free, unaccompanied and without requiring a fare product or identification. Children aged 5 and under must be accompanied by someone 12 years or older to ride the bus, and must board and depart at the same stop as their guardian. The proposal is to expand this program to include all young people, up to, and including the age of 18.

Young people, aged 13-18 are currently excluded from this important program in BC. Youth aged 13-18 in the crucial developmental stage of adolescence need basic mobility more than ever to thrive in every aspect of their lives. Our youths are the future of this province and our most valuable resource. We must ensure their right to access school and thrive, while BC brings up new generations who choose sustainable transportation for life.

A universal approach, ensures that no youth is left behind or singled out due to their socioeconomic status. We cannot separate the right of every youth to access their school from their access to the mobility to do so.

Youth mobility is also about the opportunity to participate in important extra-curricular activities and the freedom youth need to grow, whether they are accessing a pool, a

drop-in centre, a job, a shelter, a counsellor's office, or an extended family member's home across town.

For low-income youth whose families may not have access to a vehicle and the means to provide transit passes, youth facing marginalization, and youth living in a household where adult guardian(s) work full time, transit access is a survival lifeline to access shelter, school, jobs, community programs, support services, health care, and food security.

The cost of ensuring at-risk youth can access the essential programs and services funded to support youth outcomes in BC is downloaded onto non-profits that often struggle to 'remove the access barrier' of lack of access to transit. That youth-in-need may miss the lifesaving supports available in BC due to mobility poverty and lack of access to transit is an avoidable travesty solved with free transit up to age 18.

The City of Vancouver ran a free transit pilot project in 2021-2022, and this pilot project captured the impact of unlimited, free transit on low-income youth from their parents' perspectives. Youth took more initiative to organize their lives; parents witnessed increased uptake of after-school activities, mental health support services, and increased social inclusion. There was an overall increase in mental health and well-being among youth since they were no longer left behind or had to experience shame when asking for free rides. We can no longer afford to leave our most valuable resource behind, our youth, and we must build a new culture of green transportation rooted in generations to come.

The benefits of this program are wide-ranging, and include:

Increased accessibility: Young people, especially those from low-income families, may face barriers to accessing public transportation due to cost. Making transit free removes this barrier and ensures that young people can access education, employment, social activities, and other essential services more easily.

Hello Todd:

It was good to meet with you last week and bring you up to date on our endeavours to develop a new community hatchery relocated to Wolf Creek. You may recall our discussion and shared concern regarding the protracted delay in salmon enhancement activities - especially for the Kloya River chinook stock which desperately needs ongoing conservation. Since then we have fleshed out a temporary enhancement plan with Department of Fisheries officials and believe a letter of support from the District of Port Edward would be most helpful in securing approval for this work.

I have provided a draft letter for your consideration (see below). Please feel free to call and discuss this further if you have any questions. Our proposal would require an incubation box for Kloya chinook to be temporarily installed below the intake dam with a flexible pipeline providing the required flow. The emergent fry would be subsequently transported for short-term rearing to Prudhomme Lake. As committed in our Agreement in Principle we would work closely with the District of Port Edward to communicate fully and to minimize any concerns.

Your prompt attention to our request is greatly appreciated given the time sensitive nature of our application for temporary salmon enhancement approval to the agencies.

RECOMMENDATION: That Council makes a motion to appoint Kaitlyn Kowal to be the new Port Edward representative on the Accessibility Committee.

REASON FOR REPORT:

The previous representative provided us notice of her resignation and a search started for a new candidate. We advertised this vacancy over the past two months in our newsletter, we received one response, Kaitlyn Kowal. Kaitlyn lives in Port Edward and we feel she would be a great addition to the committee.

BACKGROUND:

The Accessibility Committee group consists of the City of Prince Rupert, the Prince Rupert Library, the North Coast Regional District and the District of Port Edward and it's been established for about a year. This group is part of the requirements of the Accessibility BC Act; 1: where an accessibility committee must be established; 2: Develop an accessibility plan; and 3: a mechanism for community feedback on accessibility needs to be in place.

DISCUSSION:

The Isolation Valve Project is a crucial infrastructure initiative aimed at enhancing the efficiency and reliability of utility services within the Cedar Street, Hillcrest, and Jubilee neighborhood area. Currently, the absence of isolation valves necessitates the shutdown of the entire town to facilitate repairs or expansions, resulting in significant inconvenience and economic disruption. This report provides essential background information, rationale, and proposed strategies for the successful implementation of the Isolation Valve Project.

BACKGROUND:

The Cedar Street, Hillcrest, and Jubilee neighborhood area serves as a vital hub within our municipality, accommodating a diverse range of residential, commercial, and industrial activities. However, the absence of isolation valves poses a significant challenge to the maintenance and expansion of essential infrastructure, including water, gas, and sewage systems. Without isolation valves, any repair or enhancement efforts require the complete shutdown of services across the entire town, leading to widespread disruption, loss of productivity, and economic ramifications.

The Isolation Valve Project is imperative for several reasons:

Minimizing Disruption: By strategically installing isolation valves within the target area, we can localize maintenance and repair activities, minimizing the need for town-wide shutdowns and mitigating disruption to residents, businesses, and essential services.

Enhancing Infrastructure Resilience: Isolation valves enhance the resilience of our utility infrastructure by allowing for swift and targeted responses to emergencies such as leaks, breaks, or system failures.

This capability reduces the duration and scope of service interruptions, improving overall system reliability and customer satisfaction.

Facilitating Future Growth: The installation of isolation valves creates a foundation for future infrastructure expansion and development within the Cedar Street, Hillcrest, and Jubilee neighborhood.

With localized maintenance capabilities, we can accommodate the growth needs of our community without resorting to town-wide shutdowns, thereby fostering sustainable development and economic prosperity.

In response to directives from the Province and in compliance with Dam Safety Regulations, we issued this Request for Proposal (RFP) to develop comprehensive Operating and Emergency Plans for Alwyn Lake and Wolf Creek Dam.

Following a series of audits conducted in 2009, 2012, 2016, and most recently in September 2023, it has been determined that adherence to Dam Safety Regulations necessitates the formulation of detailed operational strategies and emergency protocols for both dams.

The objective of this RFP is to procure the expertise necessary to create robust plans that ensure the safe and effective operation of Alwyn Lake and Wolf Creek Dam under various conditions, as well as establish procedures to swiftly and efficiently respond to emergencies.
